How do I raise an adjustment on a Class 4 site?

• Shippers can raise an **RFA** query in **CMS**

How do I raise an adjustment for a Class 1 site?

• Shippers can raise a **DMQ** in **CMS** which will go directly to the relevant DMSP

How do I convert volume into an energy?

• The calculation is as follows:

Volume x Calorific Value (CV) / 3.6

 An average CV of 39.6 can be used to get a close indication of the actual energy
