Change Overview

XRN4679 – Requiring a Meter Read following a change of Local Distribution Zone or Exit Zone

When the Local Distribution Zone or Exit Zone that a Supply Meter Point is amended SAP ISU requires a Meter Reading to be entered. By entering a reading this ensures that the UK Link system has distinct periods against which to levy the transportation charges associated with the different zones.

Estimation of a Meter reading by CDSP with an explicit read reason code being provided to the Shipper User

Estimation of a Meter reading by CDSP reusing an existing read reason code being provided to the Shipper User


Option 1 - High Level Impact Assessment

1 - Estimation of a Meter reading by CDSP with an explicit read reason code being provided to the Shipper User

As part of the solution, a new read reason code will be configured in SAP ISU. This will be used for the meter reading order to get created whenever there is a change in Exit Zone or LDZ of the site which will be then picked up for the read estimation. Once the read is estimated, MBR file will be triggered containing the new read reason code in the M03 record. For successful delivery of MBR file, the new read reason code will be configured in Marketflow & SAP PO.

For SAP BW, the read type and the read reason code needs to be defined and mapped for the reports. This will eventually display on the external facing screens in DES.

A report needs to build in order to add an estimated reading on outstanding LDZ / EZ Changes. The report will scan the system for all EZ/LDZ changes where no read is present and update the meter reading. The input will be the date till which EZ/LDZ change needs to be scanned.



Assumptions

- New read reason code needs to be defined SAP ISU/PO/Marketflow
- New read type & read reason code needs to be defined and mapped and no other derivation logic in considered for SAP BW / DES.
- Trigger will be created only on the update of Exit zone / LDZ for an MPRN.
- No Market trails has been considered
- CSEP amendments trigger will be created only on Site takeover.
- CAI file will not be impacted



2 - Estimation of a Meter reading by CDSP reusing an existing read reason code being provided to the Shipper User

Once the estimation runs, MBR file will be triggered which will contain the newly mapped read reason code in it.

A report needs to build in order to add an estimated reading on outstanding LDZ / EZ Changes. The report will scan the system for all EZ/LDZ changes where no read is present and update the meter reading. The input will be the date till which EZ/LDZ change needs to be scanned.



Assumptions

- Existing read reason code needs to be defined and mapped
- Trigger will be created only on the update of Exit zone / LDZ for an MPRN.
- CSEP amendments trigger will be created only on Site takeover.
- CAI file will not be impacted
- End to end testing to be performed from SAP ISU to DES.
