# **CSS Registration Secured Active Synchronisation Message Processing**



#### **CSS Registration Secured Active Synch Message**

- BRD feedback was received regarding how UK Link will be handling a CSS secured active registration synchronisation message when a pending registration message has not being received in advance, which would lead to an error being generated within UK Link.
- As the Secured Active message dataset does not provide UK Link with any information regarding who
  the incoming shipper or supplier is UK Link is unable to process the CSS message where a Pending
  Registration notification has not been received.
