Executive Summary

Key Programme Updates

- To date, all Xoserve key internal and external milestones have been met
- **Transition:** Internal and external preparatory activities continue towards DM Live Rehearsal and Transition test phases. Currently the Programme are progressing CRD-071 which proposes to de-scope In-Flights from the transitional period.
- SoLR; Discussions continue at Programme level and at ChMC.
- Internal Testing: Core testing has completed. Change requests are being progressed through internal testing in line with the Switching Programme release cycles and/or milestones.
- **Data Migration:** Progressing to plan, Xoserve do have a couple of defects we are tracking through to fix. Presently we are expecting the testing of at least one of the defects to take place during Live Rehearsal.
- Market Trials: The CR to remove Market Trials has progressed through the Ofgem Change Advisory Team
 meeting. The CR has now been presented to the Ofgem Testing Workgroups for the relevant milestones to be
 removed from the Programme Plan.
