1. General Meeting Administration

1a. Welcome and Introductions

Paul Orsler (PO) started the meeting and informed all attendees that this meeting is being audio recorded for the purpose of producing the summary and each recording will be deleted once the relevant summary has been signed off. PO informed the attendees of the agenda.

1b. Previous DSG Meeting Summary and Action Updates

PO asked for feedback on the summary for the previous Delivery Sub-Group (DSG) occurrence; no comments were received. The summary was approved.

2. Changes in Change Development

2a. New Change Proposals – Initial Overview of the Change

2a.i. XRN 5892 - Ring-fenced DSC Budget to support Allocation of Unidentified Gas Value-Add Activities

PO gave an overview of slide 6 and noted this change will not require a technical change. A Solution Change Pack will be created to cover off the different options in terms of the budgetary value available to the unidentified gas expert. This change relates to UNC modification 0868, which was approved in January. Xoserve are looking to undertake this set of work to ensure that we can be compliant with the arrangements that have been approved in that modification.

2b. Change Proposal Initial View Representations – None for this meeting

2c. Undergoing Solution Options Impact Assessment Review

2c.i. XRN 5808 - Providing Notification to DNs and IGTs for Capacity and Nomination Referrals Awaiting Action

Benjamin Snell (BS) provided an update on slides 11 – 20. BS noted that currently there is no notification (e.g. email) sent to the DNO to inform them that there is a Referral within the UK Link Portal that is awaiting assessment and action. This change will cover the creation of a specific notification to the DNO/IGT and will reduce the potential of undue delay in responding to Shippers and their customers when a referral decision is required.

Details of the two solution options were covered in the slides.

Andy Clasper (AC), Sally Hardman (SH) and Tom Stuart (TS) stated approval of solution option number 2 – i.e. Referral Manual Check Process.

3. Changes in Detailed Design

3b. Requirements Clarification

3a.i. XRN 5872 Updates to the Annual Quantity (AQ) amendment process (MOD 0876S)

James Barlow presented the customer requirements for XRN 5872, these will be used to progress the change through development, creating solution option(s) and, ultimately, the detailed design. No comments were made by DSG representatives.

4. Major Release Update

4a. XRN5818 – February 25 Major Release

PO highlighted the points below –

- Implementation date of 28th February and is coming towards the end of its post implementation support phase.
- In addition, certain scenarios have been identified that Xoserve will be supporting IGTs to correct related data held in UK Link – with this requiring engagement with Shipper customers.

4b. XRN5888 – Minor Release 14

- Implementation is currently planned for May 2025
- The Release comprises of two changes - XRN 5769 Changes required to Broadcast Service (Minor ones) and XRN 5549 Automation of the UK Link and Gemini Mismatch analysis and correction process

4c. March 2025 DDP Update

- PO provided an overview of the DDP roadmap. This included an update on the progress of DDP Release 6, which is due to complete at the end of March. PO also clarified the scope of DDP Release 1, which forms the first Release of DDP in BP25. No comments were raised by DSG representatives.
